Pratt Street** – Class “D” Beer, Wine & Liquor license – **Violation of Rule 3.02** “Licensees shall cooperate with representatives of the Board, members of the Police Department, Health Department, Building Engineer’s office, Grand Jury and representatives of other governmental agencies whenever any such persons are on official business” from November 29, 2012 to date (Re: Licensee has made no payments on \$925 fine owed from November 29, 2012 hearing; letter sent to licensee on January 8, 2013 concerning need for immediate payment and/or payment plan)

Haven Street** – Class “B” Beer, Wine & Liquor license - **Violation of Article 2B §10-505** “Every person receiving a license under the provisions of this article shall frame his license under glass and place the same so that it shall at all times be conspicuous and easily read in his place of business ...” on December 30, 2012 and on January 1, 2013 (Re: License not conspicuously displayed as required by law); **Violation of Rule 4.18** “No licensee shall commit or allow the commission on his premises of any act which shall be contrary to any federal, state or local statute, law or ordinance or against the public peace, safety, health, welfare, quiet or morals” on December 30, 2012 and January 1, 2013 (Re: Liquor license states no live entertainment or dancing; police observed approximately 100 people dancing) and on January 1, 2013 (Re: Police officer observed ten people dancing in front of a DJ); **Violation of Rule 3.06** “Licensees shall operate their establishments at all times in accordance with the requirements of the Health Department of Baltimore City, the Building Code of Baltimore City, and the rules and regulations of the Fire Department of Baltimore City” on January 1, 2013 (Re: Side exit door was locked with a dead bolt)
