**3.03 (c) Employee Records**– July 18, 2015 – At approximately 2:00 am, Det. L.C. Greenhill of the Baltimore City Police Department responded to the establishment for the purposes of conducting a routine bar check. The bartender/store manager could not provide inspectors with employee records as required by BLLC rules and regulations.

**Violation of Rule 4.02 Inebriates and Addicts** – September 5, 2015 – At approximately 1:40 am, BLLC Inspector Chrissomallis responded to the establishment after being contacted by Baltimore City Police for a call concerning inebriated patrons.

**Violation of Rule 3.12 Public Welfare** - September 5, 2015 – At approximately 1:40 am, BLLC Inspector Chrissomallis responded to the establishment after being contacted by Baltimore City Police for a call concerning inebriated patrons and an alleged assault had occurred in the establishment causing the extraction of those individuals out of the bar and into public street.

2. Thomas Hamrick & Yenys Silva, Carolina Tex-Mex Restaurant, LLC T/a Carolina's Tex-Mex Restaurant, 505 S. Broadway – Class "B" Beer, Wine & Liquor License - Violation of Rule 4.05 Prohibited Hours – August 16, 2015 – At approximately 1:50 am, BLLC Inspector Chrissomallis and Lt. Coburn of the Baltimore City Police Department conducted a routine check of the establishment. At the time of their inspection, both noticed numerous people consuming alcoholic beverages. Lt. Coburn advised the manager on duty that she had 10 minutes to clear out the establishment so as not to be in violation of BLLC rules and regulations. Both Chrissomallis and Coburn waited in the establishment. At 2:05 am, Chrissomallis and Coburn noticed 11 patrons in the establishment, 7 of which were drinking alcoholic beverages. Police then cleared the establishment and the manager was informed of the violation.

**Violation of Rule 3.03 (c) Employee Records**– August 16, 2015 – At approximately 1:50 am, BLLC Inspector Chrissomallis and Lt. Coburn of the Baltimore City Police Department conducted a routine check of the establishment. While conducting their investigation, the inspectors and police asked for copies of the employee records of all personnel employed and working at the establishment. The bartender/store manager could not provide inspectors with employee records as required by BLLC rules and regulations.

**Violation of Rule 4.18 Illegal Conduct** – August 16, 2015 – At approximately 1:50 am, BLLC Inspector Chrissomallis and Lt. Coburn of the Baltimore City Police Department conducted a routine check of the establishment. While conducting their investigation, the inspectors and police asked for a copy of the Trader's License. The manager provided a copy that was expired. The BLLC Inspector informed her of the violation.

**Violation of Rule 3.12 Public Welfare** August 16, 2015 – At approximately 1:50 am, BLLC Inspector Chrissomallis and Lt. Coburn of the Baltimore City

Police Department conducted a routine check of the establishment. After clearing the establishment for a violation of Prohibited hours, BLLC inspector noticed a patron of the establishment – who he had previously seen inside of the establishment – directly outside of the establishment urinating on the building next door.

- 3. Jin Hua Lin, Fan Yuan Corporation T/a Keepers Market, 3601 Brehms Lane Class "A" Beer & Wine License Violation of Rule 4.18 Illegal Conduct—August 8, 2015 At approximately 11:20 pm, Det. Garrett and Det. L.C. Greenhill of the Baltimore City Police Department conducted an undercover investigation to determine if illegal tobacco sales were occurring at the establishment. Det. Garrett entered the establishment in an undercover capacity and asked if he could purchase a single "loose" cigarette. At the time, the store clerk, later identified as Jin Hau Lin, sold Det. Garrett the single "loose" cigarette. Det. Garrett utilized departmental funds to purchase the cigarette. Det. Garrett then advised Det. Greenhill of the purchase and Det. Greenhill responded to the establishment. Upon confirming that the sale of the "loose" cigarette took place, Det. Greenhill advised Ms. Lin who was in control of the establishment that selling "loose" cigarettes was a criminal violation and it would be reported to the Liquor Board
- 4. Sierra Dennison & Vincent Griffin, GM Holdings, Inc. T/a Lust, 408 E. Baltimore Street Class "BD7" Beer, Wine & Liquor License/Adult Entertainment Violation of Rule 4.18 Illegal Conduct August 4, 2015 At approximately 5:45pm, Agent Fosler visited the establishment to conduct a routine inspection. At the time of the inspection, Agent Fosler observed numerous dancers performing adult entertainment in the establishment. When Agent Fosler asked for a copy of the establishment's Adult Entertainment license the bar manager/licensee could not produce it. In addition, the bar manager/licensee failed to produce a copy of an active trader's license. Further investigation revealed that the establishment failed to renew their Adult Entertainment license until August 10, 2015 and as of August 18, 2015 the establishment had failed to obtain an active trader's license. Agent Fosler notified the establishment's bar manager/licensee of the violations upon confirmation.

Violation of AE Rule 9 Codes Compliance – August 4, 2015 – At approximately 5:45pm, Agent Fosler visited the establishment to conduct a routine inspection. At the time of the inspection, Agent Fosler observed numerous dancers performing adult entertainment in the establishment. When Agent Fosler asked for a copy of the establishment's Adult Entertainment license the bar manager/licensee could not produce it. In addition, the bar manager/licensee failed to produce a copy of an active trader's license. Further investigation revealed that the establishment failed to renew their Adult Entertainment license until August 10, 2015 and as of August 18, 2015 the establishment had

failed to obtain an active trader's license. Agent Fosler notified the establishment's bar manager/licensee of the violations upon confirmation.

Report Facts: On Saturday September 5, 2015 at approx. 1:40 am I Inspector Chrissomallis while on duty received a call from the LT. on duty in the Southeast District about a 911 call to the establishment known as Two Louey's located at 200 South Haven Street in the City of Baltimore and the State of Maryland. After arriving to the location I was met by Captain Clinedinst and Sgt. Thomas Shafer who explained to me that two individuals later identified as Roberto Anonio Sosa with a Date of Birth of 8/21/1997 and Jose Juani Perez with a DOB of 7/1/1996 had called Police because after being in the establishment for a couple of hours they were escorted out of the bar and in the process they were assaulted. After determining that both individuals were under the legal age to consume Alcohol in the State of Maryland Sgt. Shafer called for a Spanish speaking officer which later was told by the individuals that they had been drinking at the establishment. I entered the establishment and was met by security 1. Mr. Roberto Arias DOB 3/25/1974 identified by a State of Maryland Identification Card and 2. Terrell Parrish DOB 4/4/1986 Identified by a State of Maryland Identification card. At that time they stated that the two individuals were escorted out of the bar after being inside drinking. They both stated that they however never assaulted them. While speaking with the security a young looking Hispanic female which I estimated her age to be between 14 and 17 years of age and also estimated by Captain Clinedinst to also be between 14 and 17 years old walked by us. She was visually under the influence and could not walk straight. At that time I asked the female if she had identification on her which she responded no. At that time I asked to speak with a Manager on Duty which no individual would come forward as the manager or the individual in charge. I explained to the staff that if there was not a person willing to act as a manager of the establishment that I felt that the welfare of the public was at risk and I would have to remove the license from the establishment till an individual responsible for the operation was established. At that time 2 females came forward as Managers. The two managers were identified as 1. Blanca Isabel Pesquera DOB 6/04/1976 identified by a Republic of Honduras identification card. And 2. Heydy Rosario Cruz Banegas DOB 7/1/1994 identified by a Republic of Honduras passport. I explained to them that the individuals that had called the police and that were drinking in the bar were not of age and it was a liquor board violation. Talso explained to her that the female that we asked for identification did not have anv.

At that that I determined that the establishment was in violation of Rule 4.01

Police and Inspector Chrissomallis left the location at approx. 2.05am.

On August 16, 2015 at approx. 1:50 am while on duty Inspector Chrissomallis from the Baltimore City Liquor Board working with LT. Colburn from the Baltimore City Police Department Southeast District entered the establishment located at 505 S. 
