(Re: September 21, 2013, BCPD responded for crowd control, patrons became unruly when notified that the establishment was at capacity and no one else was being admitted)

Violation of Rule 4.18 "No licensee shall commit or allow the commission on his premises of any act which shall be contrary to any federal, state or local statute, law or ordinance or against the public peace, safety, health, welfare, quiet or morals." (Re: September 21, 2013, establishment over capacity, capacity rated at 250, first floor crowd estimated at 315)

Violation of Rule 3.02 "Licensees shall cooperate with representative of the Board, members of the Police Department, Health Department, Building Engineer's Office, Grand Jury, and representatives of other governmental agencies whenever any such persons are on official business" (Re: September 21, 2013, employee refused to present liquor license when requested by police officer)

Violation of Rule 3.02 "Licensees shall cooperate with representative of the Board, members of the Police Department, Health Department, Building Engineer's Office, Grand Jury, and representatives of other governmental agencies whenever any such persons are on official business" (Re: Police advised employee that no one else was to be admitted to the club, officers observed unknown employee allowing patrons to enter at the rear entrance)

Violation of Rule 3.12 "Licensees shall operate their establishments in such a manner as to avoid disturbing the peace, safety, health, quiet, and general welfare of the community." (Re: January 13, 2014, police officer attempting to break up fight outside of establishment was punched in the face by patron)

Fagley Street – Class "BD7" Beer, Wine & Liquor License – Violation of Rule 3.12 "Licensees shall operate their establishments in such a manner as to avoid disturbing the peace, safety, health, quiet, and general welfare of the community." (Re: February 23, 2014, police found that a firearm had been discharged inside establishment, patrons assaulted inside and outside of the establishment)

Such records shall be open for inspection at all time by duly authorized representatives of the Board, the Police Department of Baltimore City, and other governmental agencies." (Re: November 5, 2013, no employee records for 14 dancers working at the establishments)

Package goods, if sold, must be sold over a bar and not in a separate package goods store department, and/or section unless otherwise previously approved pursuant to subsection (2) of this rule. A separate package goods store, department and/or section is defined as an area within the licensed premises which has as its primary activity the sale of package good and in which no on-premises consumption regularly takes place." (Re: December 4, 2013, police denied entrance to the bar area of establishment)

Wesley Ivey & Western Ivey, Ivey Corporation T/a Royal Casino, 1515-19 Pennsylvania Avenue – Class "BD7" Beer, Wine & Liquor License - Violation of Rule 5.03(a) "The holder of a Class BD7 Beer, Wine and Liquor license must operate an on-premises consumption establishment with on-premise service at a bar, tables or other suitable furniture. Package goods, if sold, must be sold over a bar and not in a separate package goods store department, and/or section unless otherwise previously approved pursuant to subsection (2) of this rule. A separate package goods store, department and/or section is defined as an area within the licensed premises which has as its primary activity the sale of package good and in which no on-premises consumption regularly takes place." (Re: December 4, 2013, police denied entrance to the bar area of establishment)

T/a Sherrie's Show Bar, 3821-23 Pulaski Highway – Class "BD7" Beer, Wine & Liquor License - Violation of Rule 4.17(a) "No licensee shall permit or suffer his premises to be used for the purpose of any sexual activity, nor shall any licensee permit or suffer any employee, patron or frequenter to solicit any person for prostitution or other immoral purposes" (Re: December 11, 2013, dancer solicited police offer for sexual intercourse)

Lombard Street – Class "BD7" Beer, Wine & Liquor License - Violation of Rule 4.18 "No licensee shall permit any person to consume alcoholic beverages on the licensed premises during hours when such sales are prohibited by law" (Re: October 20, 2013, patrons outside establishment with open containers)

Pedro Rojas & Carlos Sotelo, Amigos Bar, Inc. T/a Amigos Bar, 400 S. Eaton Street – Class "D" Beer, Wine & Liquor License - **Violation of Rule 4.05** "No licensee shall permit any person to consume alcoholic beverages on the licensed premises during hours when such sales are prohibited by law" (Re: September 28, 2013, patrons seated at bar with beers during prohibited hours)

Violation of Rule 3.12 Licensees shall operate their establishments in such a manner as to avoid disturbing the peace, safety, health, quiet, and general welfare of the community." (Re: January 14, 2014, Liquor Board agent found loud music at a level that disturbed the peace and quiet of the community)

Clinton Street – Class "BD7" Beer, Wine & Liquor License - Violation of Rule 4.18 "No licensee shall permit any person to consume alcoholic beverages on the licensed premises during hours when such sales are prohibited by law" (Re: October 4, 2013, no valid traders license)

Violation of Rule 4.10(a) "No licensee shall purchase alcoholic beverages except from a duly licensed manufacturer or wholesaler, not shall any licensee sell to any other licensee any alcoholic beverages; and no licensee shall, at any time, keep or permit to be kept upon the licensed premises, any alcoholic beverages unless purchased in accordance with the Rule." (October 4, 2013, Agent from Comptroller's office confiscated two (2) bottles of liquor with retail stickers affixed)
